"Therefore a man shall leave his father and mother and be joined to his wife, and they shall become one flesh." -Genesis 2:24

California Supreme Court ruled in 1859 that "the first purpose of matrimony, by the laws of nature and society, is procreation."

Bertrand Russell stated that "it is through children alone that sexual relations become important to society, and worthy to be taken cognizance of by a legal institution."

Court papers filed in July of 2014 state that "the State regulates marriage for the primary purpose of channeling potentially procreative sexual relationships into enduring unions for the sake of joining children to both their mother and their father... Same-sex couples can never provide a child with both her biological mother and her biological father."

Before this case smae-sex marriage was reconized in 36 states, but not all of them and even after the case same-sex marriage was not reconized everywhere.

The Oberefell v. Hodges case

This case lasted 2 years (2012-2014) and was the case that guaranteed same-sex couples marriage.

Each state had the chose to reconize same-sex marriage until 2015 when the Supreme court made is legal everywhere.

Texas was not the only place to keep refusing marriage licences for same-sex couples, most of the southern states were refusing.

Southern states tend to be more religious than the northern causing them to be harder to change.

The law to legalize same-sex marriage was passed in 2008 in California and then recalled in less than a year.

The government had so many complaints from the religious community in California that they took back the law, so that they would stop getting harassed and sent death threats.

Even in 2019 there is still a place in Texas that refuses to give marriage licences to same-sex couple

Even after same-sex marriage was made legal everywhere, there were still counties that didn't reconize it because of their very strong religious beliefs.
